### AAUW TACOMA BRANCH PHILANTHROPY

Our mission is to advance equity for women and girls through education, research, advocacy and philanthropy. For Tacoma branch members, there are several opportunities to contribute to the philanthropy part of the mission. Here is a summary of the funds where your contribution will be tax deductible and make a difference in promoting equity. The branch membership form for new and renewing members has places for you to submit your donations along with your dues

**Greater Tacoma Community Foundation** (GTCF). AAUW-Tacoma has a permanent fund in the GTCF. We use the income from this fund to support our branch scholarships. We have been able to draw around \$2000 per year from the fund. We will not be able to expand our scholarships for women in college in Pierce county—so necessary in these times of rising tuition and unsustainable student debt—unless we can find a way to increase the capital in the fund. If you want to make a donation that will sustain and grow Tacoma Branch scholarships, the GTCF is the way to go.

**AAUW Educational Opportunities Fund** (EOF) offers a variety of national fellowships and grants to support research such as American Fellowships, Career Development Grants, Community Action Grants and International Fellowships. The EOF houses the Tacoma Centennial Fund that branch members and friends topped off at \$100.000 in 2011. As part of the EOF endowment, our centennial fund supports research for women scholars in Washington State.

**Legal Advocacy Fund** (LAF) is a national AAUW fund that works to combat sex discrimination in higher education and the workplace. It partners with other civil and women's rights organizations to support strategic litigation that affects women in all workplaces. It also has an education mission, offering branches Campus Outreach Grants, which help branch members hold a campus anti discrimination event, and provides a resource library and online advocacy tools to the public. In recent years, LAF initiatives have helped many college campuses develop policies to confront sexual assault. Through the Title IX program in a box, LAF engaged branches throughout the country in an effort to assess compliance of high schools with requirements for equity in sports and athletics.
