Our guest speaker will be Dr. Kim Bobby, the University of Puget Sound's Chief Diversity Officer and Associate Professor School of Education. Dr. Bobby was appointed by the University President to serve as the first Chief Diversity Officer. She reports to the President and Academic Vice President (Dean of the University) and works with other members of the university's senior staff to provide leadership for diversity initiatives across campus. A fundamental purpose of the position is to serve the educational mission of the institution by helping to plan, coordinate, implement, and assess operational and strategic goals related to diversity; primary responsibility for coordinating implementation of the university's strategic plan for diversity and directing early college access and achievement programs, including supervision of program staff, budget development and administration. She examines climate and demographic patterns for faculty, staff and students; consultant to administrative and academic departments regarding climate, work place competencies and analysis of patterns throughout the system; serves as Affirmative Action Officer and Title IX officer.

### **President's Words**

The issue of "single sex" education flared to the front pages of our local paper early last month as we learned that a so-called "bold educational program" at Jason Lee Middle School ended after Tacoma Public Schools officials learned that it violated Washington State education regulations. The newspaper <a href="article">article</a>, a follow-up <a href="editorial">editorial</a> and a subsequent <a href="column">column</a> by News Tribune columnist, Peter Callahan, went a long way toward showcasing the lack of knowledge this publication and it's editorial and reporting staff have about gender based education and the conflicting research on the issue. Mr. Callahan inflammatorily declared, "Opposition (to gender based education) comes mostly from women's groups and seems based on civil-rights history, especially the Jim Crow-era discrimination against blacks in public schools." Thank you Mr. Callahan for mansplaining that to me and being totally wrong.

The editorial board of The News Tribune and Mr. Callahan appear not to be aware of the conflicting research, and so they have wrongly assumed themselves to be more competent than, say, a significant body of research that questions gender-based education. Indeed a September New York Times article entitled, "Single-Sex Education Is Assailed in Report" describes a report, "The Pseudoscience of Single Sex Schooling," to be published in Science magazine by eight social scientists. In their review of the research they assert that "sex-segregated education is deeply misguided and often justified by weak, cherry-picked or misconstrued scientific claims rather than by valid scientific evidence." The strongest argument against single-sex education, the article said, is that it reduces boys' and girls' opportunities to work together, and reinforces sex stereotypes. (Me imagining this conversation with my 13 year-old youngster: "Son, why don't you have math class with girls in it?" Son: "Jeesh Mom, everyone knows girls can't do math. They split us up so we don't have to go as slow as the girls!").

In a 2008 blog post, Sara Mead said, "It would seem that recent neuroscience research shows significant differences in male and female brains and therefore educators must employ different approaches in teaching male and female students. *Unfortunately, many of the arguments for gender based education are bunk--and often have more to do with outdated gender stereotypes than the cutting edge research proponents claim they're based.*" [Emphasis mine.]

Mr. Callahan's argument that opposition by women to gender based education is simply rooted in opposition to (gender) segregation misses the target completely. There is no clear consensus or overwhelming data on the matter in the research literature. Are you familiar with the conflicting research on this issue? What is your perspective?

September 21, 2011

Subject considered: Legalization of Marijuana

The discussion began with the legal status of medical marijuana and how easy it is to get a card allowing purchase of marijuana under Washington State's current law.

The active cannabinoid found useful in treating nausea in cancer, muscle spasms in multiple sclerosis, and as an appetite enhancer in wasting diseases like anorexia is delta-9-tetrahydrocannabinol (THC). There was discussion about how THC is processed by inhaling, or in the case of a manufactured medication, through the digestive tract.

Mention was made of the differences between marijuana, a mild stimulant, and other depressive drugs derived from opiates and the relative dangers of each. We discussed the financial and social cost of substances labeled illegal versus those simply unhealthy but legal to consume. We concluded that legalization should be for any purpose, not simply medical.

Legalization has been accomplished in Portugal, with no increase in drug use. The group concurred that in the US business interests would quickly take over manufacture and distribution, but a federal regulatory agency (FDA?) would need to be closely involved with all aspects of production. Guidelines for use should follow those for tobacco and alcohol, with states making regulations.

The last part of the discussion turned to questioning why marijuana is still not legal, when the potential for tax income is so great. The group questioned who or what is currently deriving financial benefit from marijuana remaining illegal, in spite of very widespread use. The cost to local, regional and national law enforcement in the US, and in Mexico, is profound, and legalization would free funding for more important public safety initiatives.

My mother, Louise Lilly McBride graduated from the University of Montana in 1929 with a B.A. in Spanish. When she became a widow in 1944 and returned to Butte with two small daughters, the significance of that degree grew: she had "something to fall back on". The three of us spent several summers in Missoula—1948-51 while my mother earned her M. A. in Spanish

and prepared herself for her career as a college professor at Montana School of Mines (now Montana Tech). Mother was also active in the Butte branch of AAUW and became Montana state president in 1952. This early lesson of the importance of education for women ensured that there would never be any question that my sister and I, too, would go to college. Fast forward to 2005, when I retired and moved to

Tacoma. The first night I thought: "Here I've moved clear across the country to live and I don't know anyone." Remembering mother's example, I joined the Tacoma branch and started attending branch meetings. Since I had had lots of experience at my university in policy and bylaws, I volunteered to chair the bylaws committee and write a column on public policy. I served as Presidentelect and then President for two years. The opportunity to participate, find new friends among women

who share my passion for women's equality and rights, and make a difference in the organization that meant so much to my mother has been priceless.
