Happy 2011! (Is it "twenty-eleven" or two-thousand eleven"? I guess either is correct, but I like "twenty-eleven"). Anyway, I'm looking forward to another good year for the Tacoma Branch of AAUW. Of course, how good it is will depend on the participation of all our members in promoting the goals and activities of the branch. From bringing your friends to branch meetings, to volunteering to lead your interest group, to attending Lobby Day, to agreeing to serve in an elected office, there are many ways to contribute. The Nominating Committee members (Mary Trodden, Mary Letterman, and Kay Suiter) will be starting their work soon. They need to find candidates for Program VP (this could be a shared job) and Finance Officer as well as three members for the new Governance/Nominating committee. But, don't wait for them to call you; contact Mary T., Mary L., or Kay to find out more about these offices. Your branch needs YOU.

The January program will bring representatives of Tacoma Catholic Women Religious to tell us about their campaign to stop the demand for human trafficking. Sex trafficking of women and children is a problem both globally and in Pierce County. Trafficking generates an estimated \$9.5 billion yearly; these profits support other criminal activities such as money laundering, drug trafficking and human smuggling. This is not a new problem. Periodically in U.S. history, there has been public attention to trafficking. In the early 1900s Congress enacted the Mann Act that made it a federal crime to transport women across state lines for "immoral purposes". That law has been amended over the years; today it is a crime to transport anyone, male or female, from one state to another for any sexual activity deemed to be crime in the destination state. In 2000, Congress passed the Trafficking Victims Protection

**"Sister Action: What Are
These Sisters Up To?"**

Just four days after Human Trafficking Awareness Day, Sr. Marilyn Gooley will tell us how three local roman catholic religious communities, the Dominicans, the Franciscans and the Sisters of the Holy Names of Jesus and Mary—U.S. Ontario Province, became active in the "Stop the Demand" campaign. The campaign is the effort of Roman Catholic Women Religious in the Pacific Northwest in collaboration with others to raise awareness about human trafficking through vigils and education.

Mission: AAUW advances equity for women and girls through advocacy, education and research.

Vision: AAUW will be a powerful advocate and visible leader in equity and education through research, philanthropy and measurable change in critical areas impacting the lives of women and girls.

Diversity: In principle and in practice, AAUW values and seeks diversity. There shall be no barriers to full participation in this organization on the basis of gender, race, creed, age, sexual orientation, national origin, disability or class.

Act to strengthen federal laws to prosecute those bringing women and children into the country from overseas for prostitution. Washington is the only state with a special criminal law to deal with the problem of trafficking. Some organizations provide help for victims: Washington Anti-trafficking Response Network (WARN) is a coalition of organizations in Washington State that provide direct assistance. The focus of the Catholic campaign is different from WARN; it aims to educate, raise public awareness and persuade buyers (90% are men) to stop their demand for women, men and children for sexual exploitation. Come on the 15th to learn more about their work.

PUBLIC POLICY CORNER

In the December 2010 newsletter, the Public Policy Corner told the story of the defeat of the Paycheck Fairness Act. Shortly after that, there was a letter to the editor of The News Tribune claiming that there was no such thing as a wage gap between men and women; it was all a big lie. If there is a difference, the letter went on, it was due to women's choices. Well, here's some ammunition on behalf of the Paycheck Fairness Act from the Bureau of Labor Statistics, which gathers data on median weekly earnings from employers.

Of the 108 occupations where sufficient data is available, women's weekly earnings are higher than men's in only 4!

Women earn less than men in most common occupations; this means that even those jobs that are "women's jobs" such as secretaries; elementary and middle school teachers; registered nurses; cashiers; and accountants, women earnings are less than equal to men's earnings (from 75% to 95%)

Women earn less than men in the highest paying occupations; for example, the female to male earnings for physicians and surgeons where women are a third of the workforce, are only 64.2%.

Women earn less than men in the lowest paying occupations; for example, women laundry and dry-cleaning workers earn 73% of men's earnings on the average. Even maids earn 83.6% of earnings of male house-keeping cleaners.

Washington State is a winner in the 2010 census. Population growth is enough to warrant an additional seat in the House of Representatives starting in 2012. This will mean another vote in the Electoral College as well. In Washington, redistricting is done by an independent Redistricting Commission, which includes two Democrats, two Republicans and a chairman chosen by those four members. Once more localized numbers are available, the commission will begin the process of redrawing the map. Some expect the new seat will be around Olympia; others predict King County.

Experienced Member of the Month: Connie Dunkelberger

My name is Connie Dunkelberger. My life journey with AAUW began in 1964 with an AAUW tea given to honor the new graduates and give them the membership pitch. During the next 23 years of my life while my husband was in the military, AAUW was an off and on again part of my life in seven states. My participation in AAUW varied depending on my available time as I had three children to guide through the military process of adjusting to new homes every two or three years.

Since my husband Jim's retirement I have been active at the branch and state level of AAUW. I've held many offices including Tacoma branch president twice. At the Washington State level, I served as State President for the 2006-2008 term. During my tenure, I visited all but three of the State's 37 branches. In 2008, I served on the National Program Committee to help with the 2009 convention in St. Louis. I was appointed to the first Leadership Corps as a Grass roots Liaison with my term to end at the 2011 Washington, D.C. convention. I plan to apply for another term as we plan to fine-tune this national outreach effort.

My motivation stems from my parents who fostered a "go explore the world" approach to life. I grew up on a farm in North Dakota but my parents gave me a larger view of the world. The gender barrier was noted but not insurmountable in my early memories. Although disappointed by being the only girl with five boys entering the first grade in a two room rural school, my attitude quickly changed. I remember being with my Dad on the top floor of the state capitol building. I commented on how small a statue looked from the Prairie Skyscraper and the absence of women in the legislative photo gallery. He pointed to the pictures of the 1920s suggesting I might recognize someone from this time frame. Representative Minnie D. Craig, speaker of the North Dakota House of Representatives, was a member of the church my family attended. She was probably the first female in the nation to be elected to a similar state position. The Sacagawea statue was my childhood inspiration. If a woman with a baby on her back could lead men to the ocean, I could surely lead my classmates through elementary school.

SPOTLIGHTS SHINE ON AAUW FELLOWS

Jane Chen, CEO and co-founder of Embrace, was interviewed on 20/20 for her role in creating inexpensive incubators that help underweight babies keep warm in developing countries. Chen, who received a Selected Professions Fellowship from AAUW, is continuing her work to decrease infant mortality rates. Rosalind Wiseman, another AAUW fellowship and grant recipient and author of *Queen Bees and Wannabes*, appeared on the December 17 episode of *What Would You Do?* This show included a segment about bullying, an area in which Wiseman provided expertise.

AAUW Executive Director Linda Hallman contributed a story to [More.com](#) honoring Margaret Mead's birthday. Hallman highlighted some of Mead's many accomplishments as well as her AAUW Achievement Award. "Mead is still an inspiration for women to break through barriers and achieve their goals," Hallman said. "And AAUW supports women in their endeavors to do so, particularly in fields in which we are sorely underrepresented."

NATIONAL

AAUW Director of Research Catherine Hill was quoted extensively in an *Inside Higher Ed* article about recent cases of sexual harassment on college campuses. Pulling from her work on the 2006 research report, *Drawing the Line: Sexual Harassment on Campus*, Hill discussed the development of college sexual harassment policies and the lack of knowledge some individuals have about their rights. Hill said colleges need to make "those tools more easily accessible for students."

AAUW's new happy hour series inspired a blog post on *Fem 2.0. Cocktails and Convos*, a monthly D.C. happy hour devoted to women's issues, was featured in the post, which focused on why young women shy away from becoming members of organizations. Blog entries and other discussions like this are exactly the kinds of conversations AAUW hopes to engender by hosting these events.

A local Pittsburgh newspaper cited an AAUW statistic from the 2010 research report *Why So Few?* In an article on a Carnegie Science Center program that aims to develop girls as math and science leaders. The article notes that only 15 percent of female college freshmen plan to major in STEM fields.

Elect Her—Campus Women Win, AAUW's joint program with Running Start, got the thumbs up after Women's enews highlighted an Associated Press article that appeared in the *Chicago Tribune*. The AP reported on Northern Illinois University's upcoming training to prepare more women to run for elected office because "Jill Dunlap of NIU's Women's Resource Center says the campus has had only two women student association presidents ever. She hopes the program will improve that." A *Daily Chronicle* article also recognized Northern Illinois University's selection to the Elect Her—Campus Women Win program.

Two Society of Women Engineers members touted AAUW's 2010 report, *Why So Few? Women in Science, Technology, Engineering, and Mathematics*, in the organization's monthly magazine, saying the report resonated with their experiences as women engineers and may help other women feel less isolated. The article said the researchers at AAUW "present a convincing case against the idea that low numbers are due to inherent biological differences." *Why So Few* was praised again later in the publication; a media review by the same authors referred to it as a valuable resource for parents, educators, engineers, and employers.

A member of AAUW's delegation to Cuba this fall shared her experiences and lessons learned in an article in the *Cannon Falls Beacon*. The trip to Cuba—which was open to AAUW members—took a look at women's leadership there, a place where Cuba is ahead of the United States according to a White House report last year. The author, Sandy Wollschlager, said the trip provided inspiration for a solution to the uneven balance between work and family in the United States.

LAF News

On December 6, the U.S. Supreme Court agreed to decide whether 1.5 million female employees of Wal-Mart can pursue job discrimination claims in one suit or whether they'll have to split up and file against individual stores. The case—the largest employment class-action suit in the nation's history—will be argued in early 2011 and will set an important precedent. For this reason, AAUW is in communication with the case's lead lawyers about opportunities to offer financial support to the plaintiffs and to sign an amicus brief to put our organizational support behind them.

Title IX Compliance

Recently a dozen Title IX complaints were filed against high schools across the country, alleging that the schools aren't providing equal opportunities to girls and are violating Title IX. AAUW is very involved in the effort to help high schools reach the goal of Title IX compliance in athletics through community activism.

LAF's Title IX Compliance: Know the Score program provides members with materials about Title IX, high school athletics, and resources to help members find out if schools in their community are in compliance with the law. Get involved and help improve girls' opportunities to play sports.
