## "A Strange Stirring" with Stephanie Coontz

Tacoma AAUW joins the Gig Harbor and Puyallup branches of AAUW, in announcing our kick-off program on **September 22, 2012, "A Strange Stirring" with Stephanie Coontz, on the campus of Pacific Lutheran University, Ingram Hall Room 100 at 10:00 AM - 12:00 AM.** Speaking on the themes in her 2011 book, *A Strange Stirring: The Feminine Mystique and American Women at the Dawn of the 1960s*, Stephanie will share her take on the changes and continuities in women's status since the early 1960s.

Stephanie teaches history and family studies at The Evergreen State College in Olympia, WA. She also serves as Co-Chair and Director of Public Education at the Council on Contemporary Families, a non-profit, nonpartisan association of family researchers and practitioners based at the University of Illinois at Chicago. Her work has been featured in many newspapers such as The New York Times, as well as scholarly journals such as Journal of Marriage and Family, and she is frequently interviewed on national television and radio. ## PRESIDENT'S MESSAGE SEPTEMBER 2012 PHYLLIS IZANT

It's a Presidential election year and the media baloney comes fast and furious. It's gotten so bad I don't watch the political reporting on the television or I change the channel if I'm caught suddenly having to listen to the crazy. Next thing you know I've switched over to HGTV and I'm reading about kitchen redos. I can only seem to tolerate learning about the latest baloney reading online blogs. They're funnier, there's lots of well-timed cussing and there is descriptive phrasing that meets and exceeds the best satire in the nation. So, to enhance your election season joy I share with you a check list that will help you discern what you hear and read and perhaps help you make the important voting decisions you need to make in November.

### Thirteen Techniques for Truth Suppression: By David Martin

Strong, credible allegations of high-level criminal activity can bring down a government [politicians and political parties]. When the government [politicians and their political parties] lacks an effective, fact-based defense, other techniques must be employed. The success of these techniques depends heavily upon a cooperative, compliant press and a mere token opposition party.

- 1. Dummy up. If it's not reported, if it's not news, it didn't happen.
- 2. Wax indignant. This is also known as the "how dare you?" gambit.

3. Characterize the charges as "rumors" or, better yet, "wild rumors." If, in spite of the news blackout, the public is still able to learn about the suspicious facts, it can only be through "rumors."

4. Knock down straw men. Deal only with the weakest aspect of the weakest charges. Even better, create your own straw men. Make up wild rumors and give them lead play when you appear to debunk all the charges, real and fanciful alike.

5. Call the skeptics names like "conspiracy theorist," "nut," "ranter," "kook," "crackpot," and of course, "rumor monger." You must then carefully avoid fair and open debate with any of the people you have thus maligned.

6. Impugn motives. Attempt to marginalize the critics by suggesting strongly that they are not really interested in the truth but are simply pursuing a partisan political agenda or are out to make money.

7. Invoke authority. Here the controlled press and the sham opposition can be very useful.

8. Dismiss the charges as "old news."

9. Come half-clean. This is also known as "confession and avoidance" or "taking the limited hang-out route." This way, you create the impression of candor and honesty while you admit only to relatively harmless, less-than-criminal "mistakes." This stratagem often requires the embrace of a fall-back position quite different from the one originally taken.

10. Characterize the crimes as impossibly complex and the truth as ultimately unknowable.

11. Reason backward, using the deductive method with a vengeance. With thoroughly rigorous deduction, troublesome evidence is irrelevant. For example: We have a completely free press. If they know of evidence that the Bureau of Alcohol, Tobacco, and Firearms (BATF) had prior knowledge of the Oklahoma City bombing they would have reported it. They haven't reported it, so there was no prior knowledge by the BATF. Another variation on this theme involves the likelihood of a conspiracy leaker and a press that would report it.

12. Require the skeptics to solve the crime completely.

13. Change the subject. This technique includes creating and/or reporting a distraction.

## Re-Thinking Scholarships and What Women Need August 2012

As we get ready for another year in our Tacoma Branch, it is time for us to re-evaluate how we are spending our time and money as they relate to helping young women prepare for their futures. Our traditional practice has been to pull approximately \$3,000 from the GTCF and the Celia Grau funds and give two scholarships each year. The last couple of years we have also given almost \$1,000 to college women to attend the NCCWSL leadership conference.

Do we want to continue this tradition or is it time to re-think our time, money, and the need of young women as they become professionals in our current culture and career paths? Could we betters serve young women and our community by investing in other programs at the local or national levels? Perhaps we can explore these issues together and re-order or affirm our priorities. Following the suggestion of our Tacoma Branch Board, I, as scholarship chair, have agreed to convene a meeting and invite all members to come and enter the conversation about our use of time and money in our mission of supporting the education of young women.

I have scheduled a re-thinking meeting for Thursday, October 4 at 4:30 PM. We will convene at my home for about an hour and half. Use the directory for my address and phone number or email me at <u>wlejohnson@msn.com</u>. If we need more time we can schedule it for another date.

This is your official invitation, so put Tuesday, Oct. 2 at 4:30 on your calendar now. If you can't come and want to contribute to the discussion, please email or snail mail your ideas to me. We want to hear your voice now so we can include your ideas and wisdom in our activities. The Tacoma Branch belongs to all its members and we want everyone to participate in our decisions and activities.

## WHO WAS CELIA GRAU?

The branch budget for 2012-2013 in this newsletter lists income from Celia Grau—over \$3000! Who *was* Celia Grau? Celia was 24 when women got the vote in Washington and it's nice to think that she was one of the first to cast her ballot. Born in Wisconsin, she graduated from Bryn Mawr, then taught French at the University of Puget Sound. Rilla, as her friends called her, was active in Tacoma branch of AAUW in the 1950s and early 1960s. Her friends remembered her as very popular and an elegant hostess in her homes in Steilacoom and later north Tacoma. Her husband, Alfred Grau, invented a juicing machine. When Alfred died, Celia sold the patent to Vitamix (a company that still specializes in high quality blenders) and invested in real estate and stocks and bonds. She had a knack for investing and left a large estate when she died in 1980 at the age of 95. The Tacoma branch receives a percentage of the income from a trust she established. We share this income with UPS, University of Wisconsin, Bryn Mawr, the Tacoma Rescue Mission and the Animal Shelter among others. The Celia Grau Trust allows our branch to support active projects related to AAUW's mission of equity for women and girls and enables us to keep our dues low.
