# **Budget Information for the Annual Business Meeting**

# PROPOSAL FROM THE BOARD: INCREASE BRANCH DUES BY \$2 -- TO \$23 -- STARTING JULY 2016

At its February 1 meeting, the Board of Directors carefully considered and approved a proposed budget for fiscal year 2016-17 and recommended a \$2.00 increase in branch dues. Members will have the opportunity to vote on both the budget and the dues increase at the March 19 Annual General Meeting.

As you may know, branch administrative expenses may only be paid from dues income. (Branch mission expenses and projects are paid from the branch's GTCF [Greater Tacoma Community Foundation] and Celia Grau Charitable Trust funds.) When dues income is not enough, expenses must be paid from reserves. We are anticipating increases in certain administrative expenses, the largest being insurance. The branch financial bond premium, which is due November 2016, is expected to be greater than the last premium by at least \$50. Additionally, the Programs Committee is running into many situations where the branch must show proof of liability insurance when reserving meeting places. The Board has now approved branch liability insurance, which is due annually (\$200). Member recruitment benefits from branch membership in the commercial social media platform, MeetUp, for which we pay dues. The branch maintains a USPS box. These are some of the costs anticipated to rise. At this time, total proposed administrative expenses are \$1,375; if dues remain at \$21 and our membership remains at \$60, we will be required to dip into reserves (\*).

Accordingly, the Board proposes an increase of branch dues by two dollars, from \$21 to \$23 for fiscal year 2016-17. Please be aware that the Board, in making this recommendation, has thoughtfully studied next year's budgeting needs and anticipated membership. This action is necessary in order to maintain quality of branch events and programs and to prevent the use of branch reserves in order to meet the annual budget.

Dues increase must be approved by membership; specifically, a two-thirds majority of members attending the annual business meeting must vote to approve the two-dollar increase. Please join us on Saturday, March 19, to vote for our branch's sustainability! Thank you!

(\*) Yearly membership fluctuates; and thanks to the efforts of our VP/Membership, the branch has reached 60 paid members. We cannot count on consistent dues income from 60 memberships. One way you can help is to remember to invite people you know to our events and encourage more members.

# **Branch Mission Funds: Where Do They Come From?**

At the March 19 Business meeting, the branch members will award \$5,500 in grants for projects that further the branch mission to break down barriers to equity for women and girls. Where do we get this money? Most branches promote the AAUW goal of philanthropy by raising funds from members or staging yearly fundraisers such as book sales and kitchen tours. Tacoma branch benefits from the hard work and generosity of members who have gone before us. We have yearly income from the AAUW fund at the Greater Tacoma Community Foundation (GTCF) and the Celia Grau Trust.

**GTCF:** Over 25 years ago, Tacoma branch established a permanent endowed fund with the Community Foundation. Its value generally is between \$50,000 and \$55,000 dollars. Each year, based on Foundation policy, the branch receives a distribution of the income from the fund, usually around \$2,200. These funds must be used to promote the mission of AAUW to promote equity for women and girls.

**Celia Grau Trust**: The branch budget for 2016-2017 lists income from Celia Grau received in December—over \$4000! Who *was* Celia Grau and why do we get this money? Celia was 24 when women got the vote in Washington and it's nice to think that she was one of the first to cast her ballot. Born in Wisconsin, she graduated from Bryn Mawr, then taught French at the University of Puget Sound. Rilla, as her friends called her, was active in Tacoma branch of AAUW in the 1950s and early 1960s. Her friends

remembered her as very popular and an elegant hostess in her homes in Steilacoom and later north Tacoma. Her husband, Alfred Grau, invented a juicing machine. When Alfred died, Celia sold the patent to Vitamix (a company that still specializes in high quality blenders) and invested in real estate and stocks and bonds. She had a knack for investing and left a large estate when she died in 1980 at the age of 95. The Tacoma branch receives a percentage of the income from a trust she established. We share this income with UPS, University of Wisconsin, Bryn Mawr, the Tacoma Rescue Mission and the Animal Shelter among others. The Celia Grau Trust allows our branch to support active projects related to AAUW's mission of equity for women and girls.

She attended Curtis High School, and after graduating, her father encouraged her to try Army ROTC. She accepted a four-year ROTC scholarship at the University of Tampa and finished her degree at Seattle University. She also holds a Master of Business Administration from Saint Martin's University.

Marisa was commissioned into the United States Army (Quartermaster



Corps) and went to Germany for her first assignment. She deployed to Southwest Asia with the 10<sup>th</sup> Special Forces Group during Operation Desert Storm. After her overseas tour, Marisa served in the 82<sup>nd</sup> Airborne Division as a jumpmaster and company commander.

After nearly ten years on active duty, she then transitioned into the U.S. Army Reserve (USAR) as an Assistant Professor of Military Science at Pacific Lutheran University. Marisa has spent the past 16 years in the USAR in various assignments, including battalion and brigade command. She holds the rank of colonel and currently serves as the Chief of Staff for the 102<sup>nd</sup> Training Division (Maneuver Support).

I am proud of my connection to the American Association of University Women (AAUW), and its work of advancing equity for women and girls through advocacy, education, philanthropy, and research. I received an AAUW scholarship award during my first year at Pacific Lutheran University. It was an encouraging and needed gift, when I had returned to college as a single mother. In that same year, I served as Chair of Student Media, while majoring in English, singing with the women's choir, and performing as a freelance soloist around campus. After graduating with a Bachelor of Arts degree in 1998, I continued to lead something of a renaissance life. I co-authored an original production titled Blackbird Singing for educational outreach with the Broadway Center for the Performing Arts in 2000. I performed as a spoken word artist, creating special event pieces until

2007. For the past ten years, I have been an Educational Assistant for Tacoma and Franklin Pierce Schools, providing a variety of instructional support to classroom teachers in K-12 education. It has been my pleasure to spur students, especially young girls, on to excellence. I continue to sing and perform locally, as I plan to release some original recordings and eventually retire into singer-songwriting.
